Kuv Yuav Ua Li Cas Thiaj Tau Txais Tej Kev Xav Tau Kev Pab Saib Xyuas Txhua Hnub Nyob Hauv Tsev?

Qhov tes dej num haujlwm Medi-Cal tseem ceeb uas muab tus neeg tos txais saib xyuas txhawm rau pab cov neeg xiam oobqhab kev saib xyuas ntiag tug, kev ua kev nyiam huv, kev ua hauj lwm thiab cov puas mov yog **Tej Kev Pab Cuam Hauv Vaj Hauv Tsev (IHSS, InHome Supportive Services)**. IHSS raug tsa los pab cov neeg tau nyiaj tsawg uas xiam oob qhab ntawm txhuas lub hnub nyoog kom nyob yam nyab xeeb lug hauv lawv lub tsev yog tias lawv xav ua li ntawv, zoo duas nyob hauv tsev laus los yog lwm cov chaw saib xyuas. IHSS them nyiaj rau ntau yam kev pab cuam hauv tsev uas ua los ntawm cov neeg txais tos saib xyuas, xam muaj kev saib xyuas tus kheej uas tsis yog kev kho mob kev pab saib xyuas ntiag tug xws li kev pab da dej, kev pab npaj kom txhij txhua, kev pab pub mov, kev pab hnav khaub ncaws lossis kev pab siv chav dej.
