Nug. Tes Dej Num Kev Hloov Chaw Rau Neeg Zej Zog Hauv California (CCT, California Community Transitions) yog dab tsi?

Teb. Tes Dej Num CCT yog ib tes dej num Medi-Cal uas tau txais kev pab peev muaj los ntawm Rooj Tsav Xwm Saib Xyuas Kev Pab Cuam Kev Saib Xyuas Mob Nkeeg xeev (DHCS, Department of Health Care Services) rau cov neeg uas muaj kev tuav pov hwm kho mob nkeeg los ntawm Medi-Cal thiab ua neej nyob rau hauv ib lub tsev kho mob pab ntxiv ;uas lawv yuav tsum tau tsiv ntawm ib lub chaw kho mob mus rau ntawm lawv tsev.

Nug. Kuv yuav tsim nyog tau kev pab cuam CCT no tau li cas?

Teb. Yog koj muaj koj li kev tuav pov hwm kho mob nkeeg los ntawm Medi-Cal, thiab koj tau nyob rau hauv ib lub chaw kho mob xws li ib lub tsev kho mob lossis lub tsev saib xyuas neeg laus uas zoo tau ntev tshaj 60 hnuv, thiab koj yuav tsum muaj tej kev pab cuam xws li tej uas koj tau txais nyob rau hauv lub chaw kho mob txhawm rau nyob tau yam tsis muaj leej twg pab, ces koj tsim nyog tau txais tej kev pab cuam CCT.

Nug. Cov txheej txheem CCT uas pab kuv yog dab tsi?

Teb. Ua ntej dua ntais, Tus Neeg Txuas Lus ntawm CCT nyob rau ntawm koj thaj chaw yuav tuaj ntsib koj txhawm rau tsim ib tug phiaj xwm rau koj tsiv tawm ntawm lub chaw uas koj nyob tam sim no mus rau ib qho chaw hauv lub zej zog uas koj xaiv. Qhov chaw no tuaj yeem yog koj lub tsev, koj tsev neeg lub tsev, lossis koj lub tsev xauj.

Nug. Yog kuv muaj nyiaj tsis txaus xauj tsev thiab yuav tej khoom siv hauv tsev uas kuv yuav tau nyob ntawm thaj chaw ntawv, CCT puas tseem pab tau kuv?

Teb. Pab tau, tes dej num CCT tuaj yeem pab koj nrhiav ib lub tsev xauj uas koj cov nyiaj txaus xauj thiab txaus them rau tej khoom uas yuav ua rau koj tuaj yeem mus pib nyob tau. Tes dej num CCT puav leej them nqi kho tsev, xws li tej nqaj tuav thiab tej kev thawb laub.

Nug. Puas muaj lwm yam ntxiv uas tes dej num CCT yuav ua pab kuv?

Teb. Muaj, lawv yuav pab koj txheeb nrhiav tag nrho txhua yam uas koj yuav tsum tau rau kev noj nyob hauv zej zog. Tes dej num yuav txheeb nrhiav seb cov tes dej num twg yuav muab tej kev pab cuam no. Qee yam ntawm tej kev pab cuam no yog cov txawj saib xyuas neeg laus, cov saib xyuas neeg mob hauv tsev (Tej Kev Pab Cuam Txhawb Nqa Hauv Tsev (IHSS, In Home Supportive Services)), muab tej cuab yeej tshuaj uas koj yuav tsum tau muaj rau siv nyob rau hauv koj tsev, kev thauj mus los, thiab pab kev nkag mus rau txhua yam kev pab cuam uas koj yuav tsum tau yog ib feem ntawm lub zej zog uas koj tsiv mus rau.

Nug. Tom qab tes dej num CCT pab kuv tau tsev xauj, pib nyob, thiab txheeb xyuas tej dej num thiab txhawb nqa tej uas kuv yuav tsum muaj txhawm rau noj nyobhauv zej zog, tes dej num CCT puas tau pab kuv tag?

Teb. Tsis tau, ib qho kev pab cuam uas tes dej num CCT muab yog kev tswj tuav teeb meem. Tes dej num CCT yuav cia koj li teeb meem qhib thiab muab kev pab cuam kev tuav tswj teeb meem 1 xyoos txij li thaum koj tsiv mus rau koj qhov chaw.

Nug. Kuv yuav txuas lus li cas nrog ib tug neeg ntawm tes dej num CCT?

Teb. DHCS sib cog lus nrog cov muab kev pab cuam rau zej zog hu ua Cov Koom Haum Coj CCT txhawm rau muab kev pab cuam CCT thoob plaws hauv California.
