1. Cov piv txwv ntawm cov kev txhawb nqa kev sib txuas Ius

"Cov kev txhawb nqa kev sib txuas Ius " yog cov cuab yeej lossis cov kev pab cuam uas tuaj yeem pab tus neeg xiam oob khab sib txuas Ius. Piv txwv li, Kev Sib Txuas Lus Ntxiv Thiab Txoj Kev Xaiv [Augmentative and Alternative Communication (AAC)], Thev Naus Laus Zis Muab Kev Pab Yooj Yim [Assistive Technology (AT)] lossis "Cov Cuab Yeej Siv Kho Tshwj Xeeb," yog cov twj uas tuaj yeem pab ib tus neeg txoj kev sib txuas Ius. Hauv txoj kab kev ntawm lub Tuam Tsev Ntawm Kev Rov Kho Kom Zoo Li Qub[Department of Rehabilitation (DOR)], cov cuab yeej siv uas txhawb nqa kev sib txuas Ius hu ua "thev naus laus zis rov kho kom zoo li qub," thiab suav nrog "cov cuab yeej thev naus laus zis uas muab kev pab."

Ntawm Nov yog qee cov piv txwv ntawm cov kev txhawb nqa kev sib txuas Ius:

- JAWS (Job Access with Speech) thiab lwm yam nyeem cov tshuaj ntsuam;
- Dynavox thiab lwm Cov Cuab Yeej Tsim Kho Kev Hais Lus [Dynavox and other Speech Generating Devices (SGDs)];

- PECs (Picture Exchange Communication System) thiab lwm yam qauv ntawm cov kab kev sib txuas lus uas muaj duab;
- Cov phiaj sau ntawv lossis cov phiaj tshiaj ntawv;
- Cov ntaub ntawv sau ua ntawv dig muag lossis sau loj loj;
- Cov kev pab xws li cov neeg txhais lus piav tes lossis cov neeg koom nrog kev sib txuas lus;
- Cov ntaub ntawv nyeem tawm suab;
- Cov ntaub ntawv tau muab ua ntej / ntxiv sij hawm rau kev tshuaj xyuas:
- Cov ntaub ntawv ua hom lus yooj yim;
- Siv cov neeg txhais lus lossis lwm cov kev pab txhawb nqa.

2. Tau txais cov kev txhawb nqa kev sib txuas lus los ntawm DOR

DOT tuaj yeem them rau "thev naus laus zis rov kho kom zoo li qub" uas tsim nyog rau koj kom nkag tau mus rau cov kev pab cuam ntawm DOR thiab kom ua tiav koj lub hom phiaj ua hauj lwm. DOT tuaj yeem muab txoj kev ntsuam xyuas rau koj kom pom tias lub cuab yeej thev naus laus zis yuav cia koj ua qee yam hauj lwm lossis pab ua kom nws yooj yim lossis muaj kev nyab xeeb rau koj ua qee yam hauj lwm. Cov kev pab cuam thev naus laus zis yooj yim uas DOT tuaj yeem muab kev pab suav nrog kev yuav, kev xaiv, kev phim, thiab kev cob qhia koj (thiab lwm tus raws li tsim nyog) ntawm kev siv lub cuab yeej. Yog tias koj yog tus neeg thov kev pab ntawm DOR thiab xiam oob khab uas xav tau kev sib txuas lus kom ua tiav koj cov hom phiaj ua hauj lwm, cov kev txhawb nqa thiab cov kev pab cuam yuav tsum muaj nyob hauv koj li Kev Pab Cuam Kev Kawm Rau Qee Leej [Individualized Plan for Employment (IPE)] uas yog kev thev naus laus zis rov kho kom zoo li qub.
