RE: AB 189 (Kamlager-Dove) as amended May 7, 2019 - SUPPORT

Dear Senator Skinner:

Disability Rights California (DRC), a non-profit advocacy organization that advances and protects the rights of Californians with disabilities, **supports AB 189.** This bill is scheduled for hearing before the Senate Public Safety Committee on June 18, 2019.

This bill would add qualified autism service providers, qualified autism service professionals, and qualified autism service paraprofessionals, as defined, to the list of individuals who are mandated reporters. By imposing the reporting requirements on a new class of persons, for whom failure to report specified conduct is a crime, this bill would impose a state-mandated local program.

Children with autism spectrum disorders are significantly more likely than typically developing children to be the victims of abuse, which encompasses emotional abuse, physical abuse, sexual abuse, and neglect.

Mandated reporters are individuals who are required by law to report known or suspected child maltreatment. These individuals include a peace officer, a teacher, a physician, surgeon, a psychiatrist, among others. Qualified Autism Service Practitioners are not explicitly stated under the AB 189 (Kamlager-Dove) as amended May 7, 2019 – SUPPORT Page 2 of 2

Child Abuse and Neglect Reporting Act. Studies have suggested that individuals with developmental disabilities are at a much higher level of risk of abuse than their peers.

Mandated reporters are in place to help end possible abuse or neglect at the earliest stage. If qualified autism service providers, qualified autism service professionals and qualified autism service paraprofessionals, as defined, were added to the list of mandated reporters, this would help protect children on the autism spectrum from abuse and neglect.
