RE: AB 2331 (WEBER) as amended April 30, 2018 – SUPPORT

Dear Assembly Member Gonzalez Fletcher:

Disability Rights California (DRC), a non-profit advocacy organization that advances and protects the rights of Californians with disabilities, **supports AB 2331**. This bill is scheduled for hearing in the Assembly Appropriations Committee on May 23, 2018.

AB 2331 promotes efficient redeterminations for a Medi-Cal beneficiary who has a developmental disability and is eligible for regional center services. It does so by allowing the county to use information the county acquired during the last 36 months that is relevant to the beneficiary's Medi-Cal eligibility prior to contacting the beneficiary (i.e. the consumer).

AB 2331 authorizes continued eligibility, until the county makes a specific determination based on facts, which clearly demonstrate that the consumer is no longer eligible for Medi-Cal benefits. Finally, AB 2331 requires the Department of Developmental Services (DDS), on a regular basis, to make available to the counties and the Department of Health Care Services (DHCS) a list of identifying consumers receiving services at regional centers.

DRC strongly supports this measure as it streamlines the process for Medi-

Cal eligibility redeterminations for individuals with developmental disabilities who are also eligible for regional center services. The redetermination process can be daunting, time consuming, and cumbersome for the individuals and families. Utilizing existing information that the counties already have, and allowing for coordination and information sharing between regional centers and the counties, DDS, and DHCS to verify continued eligibility of the consumer makes sense and removes unnecessary barriers for these Medi-Cal beneficiaries.
