RE: Save the California Community Transitions Program

Dear Chair Ting and Chair Arambula:

We urge you to save the California Community Transitions (CCT) program, which plays a fundamental role in helping seniors and people with disabilities transition back into the community from long-term care and institutional settings. Unfortunately, the funding for this critical program is phasing out at the federal level, and the state has not proposed its continuation beyond the end of federal funding. Specifically, we are asking the state to continue annual funding for the CCT at \$19.1 million in ongoing General Fund (GF) dollars, to reflect both the state contributions and the discontinued federal funds when those end. This upfront investment of \$19.1 million is estimated to result in a total savings of approximately \$28 million (approximately \$14 million GF).

Since 2008, the CCT program has been successful in transitioning over 3,500 individuals from institutional settings to the community. CCT transition teams work with individuals to develop a safe transition plan that identifies and connects them with the housing and community supports necessary for a successful transition, including help with activities of daily living and other supports like meal delivery. In addition, CCT is able to pay for home modifications and for items to set up the home including basic furniture – there is no other similar state program or service for this population.

These transitions result in significant savings, averaging \$60,000 total funds per participant per year. CCT participants are also less likely to be

readmitted to institutions in the future and report a higher quality of life. Therefore, not only is the CCT program cost effective, but it is in-line with the state's efforts to uphold the US Supreme Court's Olmstead decision that provides individuals the right to live in the least restrictive setting in accordance with their needs and preferences.

For these reasons, we ask you to save this valuable program with a \$19.1 million investment.
