**RE: DEAF ACCESS PROGRAM (DAP) ONGOING FUNDING INCREASE  
REQUEST – SUPPORT**

Dear Senator Pan:

Disability Rights California (DRC), the federally mandated protection and advocacy system that works to protect and advance the rights of Californians with disabilities, **supports** the request for a \$4.1 million ongoing funding increase for the Deaf Access Program (DAP) from \$4.7 million included in the Governor's proposed budget to \$8.8 million. This augmentation will provide increased access to DAP services for Deaf and Hard of Hearing individuals. This budget issue is scheduled to be heard in the Senate Budget and Fiscal Review Subcommittee #3.

Currently, the state contracts with eight agencies in eight regions across the state to provide the following services to Deaf and Hard of Hearing individuals:

- Communication Services
- Advocacy Services
- Job Development and Placement
- Information and Referral
- Counseling
- Independent Living Skills Instruction
- Community Education

However, as the population in need of DAP services continues to grow, resources for the DAP have diminished. Funding for the DAP reached \$5.8 million in Fiscal Year (FY) 1998-99. Since FY 2007-08, DAP agencies have lost a total of \$1.1 million in funding for the program – \$600,000 lost during the recession and another \$500,000 lost because of federal sequestration.

The \$4.1 million in additional ongoing funding would cover the unmet need created because of DAP agencies' loss of \$1.1 million in funding. It would also provide agencies with an additional \$3 million to serve approximately 120,000 Deaf and Hard of Hearing individuals who live in linguistically isolated households. These linguistically isolated households are often denied equal access to traditional healthcare, education, employment, and government services because of the funding shortage.
