## **Important information for San Francisco Tenants Facing Eviction**

Under the “No Eviction without Representation Act” (Tenant Right to Counsel) tenants who meet the following criteria have a right to a free attorney:

- 1) The tenant lives in San Francisco
- 2) The tenant has received an eviction notice or has been served with an unlawful detainer lawsuit (eviction); AND
- 3) The tenant is not living with their landlord
