RE: SB 906 (BEALL) as amended May 25, 2018 – SUPPORT

Dear Assembly Member Gonzalez Fletcher:

Disability Rights California (DRC), a non-profit advocacy organization that advances and protects the rights of Californians with disabilities, **supports SB 906**. This bill will soon come before you for hearing in the Assembly Appropriations Committee.

SB 906 establishes a statewide peer, parent, transition age, and family support specialist certification program as part of the state's mental health delivery system. DRC operates, as part of its ongoing programs, a peer self-advocacy program (PSA) and it is from that experience in which our support for SB 906 is grounded.

The DRC PSA and other peer support services are integral to fulfilling the goals of the Mental Health Services Act to ensure mental health services are provided based on a recovery model perspective and approach. Peer Certification recognizes the important work peers perform utilizing evidence-based practice. Certifying peer support positions reduces stigma and discrimination in the workplace and in society. The PSA experience builds trust and confidence among peers receiving services that other professionals cannot offer. PSA provides clients with a shared narrative, a lived experience of hospitalization and having lost independence and

rights. Peers know what it is like to take medications, see therapists and psychiatrists, be held involuntarily, placed on Lanterman-Petris-Short (LPS) conservatorship, etc. Often clients need to know someone else has gone through the same challenges and successfully gained their own wellness and recovery. Peers can share their mental health disability or specific experience. PSA staff can *almost always* relate it back to their own lives and experiences of trauma, providing trauma-informed services.

DRC has found that peer support creates a relationship that fosters personal responsibility and self-determination. California is one of the very few states that does not have a peer specialist and training program. Now is the time for California to embrace peer support as an evidence-based model to improve outcomes for individuals with behavioral disabilities and maximize federal Medicaid funds.
