**RE: Urgent Demand for City to Transfer Convention Center Residents to Hotel Rooms**

Dear Counsel:

Disability Rights California writes with urgency to demand the immediate transfer of Convention Center residents who have CDC-recognized underlying health conditions that place them at high risk of complications and death from COVID-19 from the inherently dangerous Convention Center to County-procured hotel rooms. At the time of this letter, our region is experiencing a deadly surge in infections and the rate of infection for asymptomatic individuals at the Convention Center is skyrocketing – increasing from 27 to 120 in less than a week.<sup>1</sup>

We understand the City has allocated millions in COVID-19 funds intended to protect the health and safety of unhoused individuals to the City's Convention Center. However, as detailed in our pending lawsuit against the City, the process is unlawful. As we warned the City in April, the failure to protect spread in the unhoused population undermines the entire region's health and safety:

The protection of unhoused people is essential to the long-term effectiveness of the order to shelter in place. ... [T]he long-term success of this strategy will be decreased if [people experiencing homelessness] do not receive adequate and timely resources to decrease their contact rate and probability of transmission. This population could become a reservoir for the virus that would enable the virus to spread amongst the entire population after the shelter-in-place order has concluded, which has been previously demonstrated with bacterial infections in unhoused communities.<sup>2</sup>

To date, the City has prevented unhoused individuals from being able to exercise the very public health measures the City urges on the general population in contradiction to its own policies and CDC guidelines. Since April, we have urged the City to cease pushing unsheltered individuals – most of whom have CDC-recognized health conditions that place them at higher risk of complications and death from COVID-19 — to the Convention Center, and to connect them to County-procured hotel rooms.

Since day one of the Convention Center's use as a homeless shelter, the City should have directed high risk unsheltered individuals to the hotel rooms – the vast majority of which remained empty during the pandemic. The City's contract regarding the use of its Convention Center as a homeless shelter explicitly incorporates the 2,000 hotel rooms, and a plan to transfer high-risk individuals to the rooms. The City purported to offer the hotel rooms at all times during the pandemic, and directed unhoused

individuals to contact the City's Homeless Outreach Team.<sup>3</sup> However, the City's Homeless Outreach Team has been pushing all unsheltered individuals to one place – the City's Convention Center. In addition, the City issued multiple press releases and played a lead role at numerous joint press conferences with the County – many held at the City's Convention Center – stating that the County-procured hotel rooms were part of the City's COVID-19 homelessness response.

Moreover, the City has a process to transfer people to the hotel rooms since the City has been transferring symptomatic people from the Convention Center to the hotel rooms for months and testing these individuals off-site. We understand this has also effectively deflated the number of infections tracked at the Convention Center.

Despite the hotel rooms being an integral part of the plan to use the Convention Center as a homeless shelter, San Diego County's occupancy rate for its procured hotel rooms was – and continues to be – one of the lowest in the State.<sup>4</sup> In fact, the County received millions less than it should have in recently State-allocated Project Roomkey funds because so many of the County-procured hotel rooms sat empty between July and November.<sup>5</sup> The hotel rooms should have been used for unhoused individuals who were pushed to the Convention Center despite being categorically eligible for the hotel rooms on account of having the CDC-recognized underlying medical conditions that place them at higher risk of complications and death from COVID-19. The hotel rooms would be FEMA-reimbursable if used as shelter and less COVID-19 funds would have been allocated to the mass shelter at the Convention Center. There is no justification for the City having placed

high risk unsheltered individuals in its Convention Center.

Given COVID-19's high propensity for rapid community spread and the inherent danger of the Convention Center, confirm immediately that all unsheltered individuals in the Convention Center will be immediately transferred to hotel rooms.
